#### **4-H Enrollment Time is Here**

Enrollment for the 2018 - 2019 4-H year is here! All members must enroll in 4HOnline to participate in the 4-H Club Program.

Returning members will need to log into their existing accounts in order to re-enroll. **Returning members DO NOT create a new account.** Your log-in is your family email address you use for 4-H. Re-enrollment needs to be completed by Dec. 1st in order to avoid a late fee. Re-enrollments will be accepted from Dec. 2 - Jan. 31 with a \$25 per member late fee.

New members will need to create a new account. New members will have until April 1 to enroll in 4HOnline, but the sooner new members are enrolled, the more time they have to work on their projects.

All members have until May 1st to make changes/add/drop projects, providing project requirements can still be met.

#### **Producer Dam Nomination Process and Due Date**

Producers classes nominations due for Beef, Sheep, Goat and Swine. Are you a 4-H member who has breeding stock and raises your own animals? There are new requirements for the Producers Classes! Nomination forms can be found on the <u>Livestock Program page</u>. Please read through the rules below.

#### **Eligibility:**

- Ownership of the dam must be in the name and sole ownership of the exhibitor. This
  means the dam must be part of the exhibitor's personal herd, not mom/dad's, family's
  or relatives' breeding stock and nominated by January 1, 2019.
- 2. Dam must be owned by the exhibitor prior to the birth of the offspring. Only offspring may be shown in producers' market or breeding classes (dam is not shown).

- 3. The 4-H member must be enrolled in the corresponding breeding project by January 1 in 4-H Online regardless if you intend to enter the breeding or market producer classes.
- 4. The Nomination Form NEW Dam's Submittal Form (top half of nomination form only) must be filled out and submitted with all required supportive documentation to the Extension Office no later than January 1. Keep a copy for your records. For cattle nominations of dams by Jan. 1, 2019 will be for calves born in 2019 to be eligible for the 2020 County Fair. This year's calves for the 2019 County Fair will follow the previous nomination rules.
- The bottom half of the Nomination Form must be completed, signed and submitted with all required supportive documentation no later than May 1. Keep a copy for your records.
- 6. There is no limit to how many animal nominations a 4-H member may make.
- 7. The breeding project record book must be completed.
- 8. The 4-H member is not required to exhibit in the breeding project at the county fair, just the producer's class.
- 9. The Club or Project Leader, Superintendent or County Agent will visit the member and take pictures while the animal is still nursing to assure that the animal was born at the exhibitor's place of residence. They must also sign and date the nomination form. These can be uploaded into your 4-H Online account, same as last year.
- 10. All market producer entries must comply with the required tag-in procedures, weight requirements and all other rules for market animals.

#### **Livestock Advisory Committee**

The Livestock Advisory Committee provides advice, program support, visibility, generates resources and assists in upholding county, state and national policies in support of the Arapahoe County 4-H Youth Development Program. They assist and advise with coordination, promotion and scheduling of events, activities and show in Arapahoe County with the CSU 4-H Youth Development Extension Agent as well as other responsibilities as outlined in their bylaws. This is specifically accomplished by serving as superintendents at the County Fair, although all members on the committee do not have to be superintendents.
